

INSTRUCTION FOR USE

Preva Pex

(Calcium Hydroxide with Iodoform Paste)

Preva Pex is a ready-to-use, radiopaque paste combining the antimicrobial properties of calcium hydroxide and iodoform. It is designed for easy placement into root canals and provides effective disinfection and temporary filling.

COMPOSITION

Iodoform, Calcium Hydroxide, Silicone Oil, Barium Sulfate

INDICATIONS FOR USE

- Temporary root canal filling in endodontic treatment
- Intracanal medicament between appointments
- Management of infected root canals
- Apexification procedures
- Resorption cases (internal and external)
- Pulpectomy procedures, especially in primary teeth

INSTRUCTIONS FOR USE

Preparation

- Isolate the tooth using a rubber dam.
- Perform cleaning and shaping of the root canal using standard endodontic procedures.
- Dry the canal using paper points.

Application

- Attach the provided dispensing tip to the syringe.
- Insert the tip into the canal, preferably short of the apex.
- Slowly inject the paste while withdrawing the tip to ensure complete canal filling.

Placement Verification

- Verify placement radiographically if required.

Temporary Sealing

- Seal the access cavity with a suitable temporary restorative material.

Removal (if required)

- Remove the paste using irrigation (e.g., saline or sodium hypochlorite) and mechanical instrumentation.

WARNINGS & PRECAUTIONS

- For professional dental use only
- Avoid extrusion beyond the root apex
- Avoid contact with eyes, skin, and oral soft tissues
- In case of accidental contact, rinse thoroughly with water
- Use appropriate protective equipment (gloves, mask, eye protection)
- Do not reuse disposable tips
- Ensure proper isolation to prevent contamination

CONTRAINDICATIONS:

- Do not use in patients with known hypersensitivity to any of the components (calcium hydroxide, iodoform, or excipients)
- Not intended for permanent root canal obturation
- Avoid use in cases where extrusion beyond the apex may cause complications

ADVERSE EFFECTS

- Possible irritation if extruded beyond apex
- Hypersensitivity reactions in susceptible individuals

STORAGE CONDITIONS

- Store in a cool, dry place
- Keep container tightly closed to prevent moisture contamination
- Protect from humidity and direct sunlight.

SHELF LIFE:

3 years from the date of manufacturing.
